

I'm excited to share with you the outcomes and impact of your Columbus Urban League – and introduce you to our updated mission to grow an inclusive economy that benefits our entire region.

First, please know that unrestricted investments are extending and intensifying our effectiveness. In three years, we've more than doubled the numbers of those we served through our workforce development initiatives, increased our outreach to entrepreneurs by 76%, and nearly doubled the numbers of people benefiting from home buyer education, credit, rental and mortgage counseling. Investments in talent, technology and organizational infrastructure clearly count – and they will continue to do so.




